4. Sale expenses not covered by the entry fees will be pro-rated, this includes advertising, catalog, postage, facilities and any other expense connected to conducting the sale.
5. **Entries will be charged the following costs:**
  - Prorated sales costs. \$200.00 of entry fees will go towards sale costs.
  - 12 % commission on sales and no sales (8% to sale manager, 1% to the auctioneer and 2% to the AWA).
  - Your AWA membership dues (if not all ready a paid member).
6. Entries are limited to pregnancies, semen and embryos. All animals represented must be registered through the AWA in order to sell.
7. Sale order will be determined by the sales management.
8. The sale may take between 30-60 business days to close. Sellers must be aware of the time to collect proceeds, clear checks and pay the bills. Only after all the bills are received can the sale be closed. JDA is acting as an agent and seller will be paid after the proceeds have been collected from the buyer. All sales and guarantees are between buyer and seller.
9. **All entries, entry fees, papers and other information must be submitted no later than August 1st, 2017.**
10. A package of catalogs will be sent to you prior to sale day. If you have not already started, begin promoting this event. Without a combined effort by all, we will not succeed on the level that we would like to see. Contact and encourage buyers from your area to attend.
11. All sold items must be released within 24 of the request of the sales management. Items will only be released once payment is received.
12. Seller is responsible for validity of all pedigrees and genetics being offered and sold.

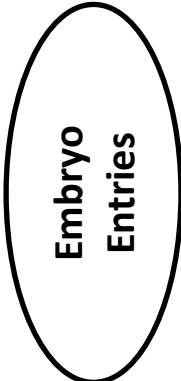

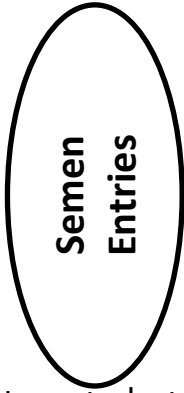
