By participating in this consignment sale, I agree to abide by all rules regarding to this sale. It is understood that James Danekas & Associates, Inc. will be doing the sale accounting for this sale and will be collecting the sale proceeds. I understand that the sale proceeds will be disbursed within a 30-60 day period following the sale.

I understand that all consignments will be charged prorated sale costs to cover shared expenses from all consignors for auctioneer, advertising, catalogs, postage, sale facilities, etc. I understand that additional sale costs (after entry fees are applied) will not exceed \$200 for live lots (females, bulls, and pregnancies) and will not exceed \$100 for frozen genetics. I do agree that a sale commission of 11% will be charged on all sales and on any floor prices or reserve bids at the final price the lot goes out of the sale ring at, either sold or unsold, and agree to pay sales expense on that final price.

As of June 8<sup>th</sup>, 2024, all live animal consignments with a floor price less than or equal to \$10,000 will be charged 5% on no-sales (4% JDA, 1% auctioneer). All live animal consignments with a floor price of greater than \$10,000 will be charged 11% on no-sales (10% JDA, 1% auctioneer).

1. **Entries are due March 3<sup>rd</sup>, 2025.** Please send all photos and footnotes pertaining to entries no later than March 10<sup>th</sup>, 2025.
2. **Entry fees: \$200 per head, \$200 per embryo lot, and \$200 per semen, flush, and pregnancy lot.** Entries that are no shows/out will forfeit all entry fees. Entry fees are non-refundable and will be applied to consignors' sale expenses.
3. Sale expenses not covered by the entry fees will be prorated. This includes all advertising, catalog, postage, veterinarian, facilities and any other expenses connected to conducting the sale.
4. **Entries will be charged the following costs:**
  - Entry fees are \$200 per entry (females, bulls, pregnancies, flush opportunities, embryos, and semen). A/B will be treated as one lot. All entry fees will go towards sale expenses.
  - All sold frozen genetics and live lots - 11% commission on sales and no sales (10% to sale manager; and 1% to the auctioneer).
  - No-Sale live lots only - 11% commission on no sales with a floor/reserve price greater than \$10,000 (10% to sale manager; and 1% to the auctioneer)
  - No-sale live lots only - 5% commission on no sales with a floor/reserve price less than or equal to \$10,000 (4% to sale manager, and 1% to the auctioneer).
  - All live lot "outs" the week of April 28<sup>th</sup> – May 3<sup>rd</sup>, 2025 will be charged a sale cost fee of \$150.
  - Any additional expenses will not exceed \$200 per lot for live lots (females, bulls, and pregnancies/flush) and will not exceed \$100 per lot for frozen genetics. (Additional expenses cover catalog typesetting, postage, online bidding platform, outside publications, ringside service, vet costs, facility, etc. that were not paid for with entry fees.)
5. Entries are limited to registered fullblood and purebred Wagyu. Females must be born after January 1<sup>st</sup>, 2019 and bulls are not to exceed 4 years of age (exceptions may apply, contact sales management with any questions). Bulls must be at least one year old unless otherwise approved by sale management (JDA). Pairs, bred females, open females, donor cows, pregnancies, flushes, bulls, semen and embryos are eligible. Bulls, semen, flushes, pregnancies and embryos can be entered but only a limited number will be allowed to sell. If any entries are not accepted, entry fees will be refunded; otherwise all entries are non-refundable. All entries are subject to refusal by sales management.
6. All live lots that plan on being present to sell must be checked in by noon on Friday May 2<sup>nd</sup>, 2025. Live lots can arrive as early as 12pm on Thursday May 1<sup>st</sup>, 2025. **Late arrivals will forfeit entry fees and will be removed from the sale.**
7. Sale facility will provide feed and water; you may bring your own feed to supplement.
8. Cattle must be sound and of good quality. Unsound, bad udders, bad eyes, under conditioned and low quality are subject to acceptance only by the sale management. All pedigrees will be screened when submitted.
9. Cattle may or may not be present to sell. It is recommended by the sale management that live entries are present; however it is not a requirement.
10. This is an un-haltered sale. However, if your entries are halter broke, please indicate this on your entry forms, as many breeders prefer halter broke cattle because they are quieter and easier to handle.
11. Sale order will be determined by the sales management.
12. **All females must be calfhood vaccinated, tested negative for TB, BVD and eligible for interstate shipment. All bulls must be semen (BSE), Trich and BVD tested and eligible for interstate shipment.** It is not required but recommended to test for Johne's. Any animals that test positive will be rejected. All testing must be completed

within 30 days of the sale date and all required paperwork must be presented to sale staff upon arrival to the sale facility. All paperwork must be completed entirely to ensure animals are eligible for interstate travel.

13. All females selling as pregnant must have the accurate breeding information listed on the entry form. Pregnancy checks are required and must be completed within 30 days of the sale date (between April 3<sup>rd</sup> and May 2<sup>nd</sup>, 2025) otherwise they will be sold as unconfirmed. (Palpation, urine, and blood tests are acceptable). You must present a signed certificate from your vet stating open status or pregnancy status upon arrival to the sale facility.
14. All cattle must be registered or in process prior to entry. For calves selling at-side, all DNA samples must be submitted to the AWA/AuAWA in order to sell. Dual registration in both USA and Australia is highly recommended.
15. All paperwork must go through the sale management office. Proceeds will be paid to consignors only after purchases have been paid for and funds have cleared the bank. Be sure to fill out the “**make proceeds check payable to**” **portion of your entry form** to ensure a timely and correct payment of your proceeds from the sale.
16. All live lot consignors are responsible for registration transfers and must be completed within 30 days of receipt of buyer payment, sale management will provide all necessary information via email for transfers. Assistance from sale management is available if needed.
17. The sale may take 30-60 business days to close. Sellers must be aware of the time to collect all proceeds, clear checks, and pay the bills. Only after all sale payments are received can the sale be closed. JDA is acting as an agent – All sales and guarantees are between buyer and seller, not sale management (JDA).
18. All consignments will receive equal space within the sale catalog. Sale management will determine the sale catalog layout.
19. A signed floor/reserve agreement must be completed and returned to the sale management by 3pm on Friday, May 2<sup>nd</sup>, 2025 in order to sell. This floor/reserve agreement will be provided to you prior to the sale. All lots without a signed floor/reserve agreement will sell with a reserve of \$0 and the consignor will be responsible for all prorated sale costs and sale fees associated with the final sale price. **Please see updated live lot commission, on no-sales only, in line #4**. Please call the JDA office with any questions regarding this commission change.
20. Two catalogs will be sent to you prior to sale day. If you have not already started, begin promoting this event. Without a combined effort by all, we will not succeed on the level that we would like to. Contact and encourage buyers from your area to attend. Let's make an all-out effort to get out the word and gather up a big crowd for this event!
21. All consignors selling live animals will receive ear tags, tagging guide, floor/reserve contract, and health cover form after the catalog is sent to the printer. Cattle must be tagged prior to arriving at the sale facility.

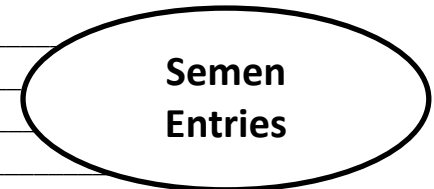
